



Things to look out for:

- New home website address- co.4honline.com
- New look!- easier interface on mobile phones!
- Enrollment fee invoices may not reflect actual cost displayed on invoice if taking more than 2 projects. Call the Extension Office for exact total and to pay.
- Enrollment fees will stay the same.
 - \$50 for first two projects
 - \$5 for each additional project
 - \$30 for Cloverbuds- no late fee after Feb 1
- New late fee for returning members after February 1- \$20
- May 1 is the last day to change any projects. You must do this through the Extension Office
- Changing clubs- contact your new leader and let them know you are moving to their club. Let your old leader know.
- Leaders, you will have to enter your birth date in order to re-enroll. The new system requires it. (sorry!)

Ways to pay enrollment fees:

- 1. Mail check made out to CSU to the Extension office (tell Melissa it is coming).
- 2. Make an appointment to come to the office and pay by cash, check or card (visa, mastercard, discover),
- 3. Call Melissa and pay over the phone with card (visa, mastercard, discover).

New Market Class: Dairy Wethers

We have exciting news! The fair board approved the sale of dairy goat wethers for the 2021 fair! This will include a new market goat class for Dairy Wethers.

New Rules:

- Dairy Wethers must be born in January the year of the fair it will be sold in or later.
- Dairy Wethers will be weigh-in and tagged/identified at Sheep and Goat weigh-in in May with other market sheep and goats. Must be banded or completely castrated when they cross the scale.
- Dairy Wethers must be at least 50 pounds at fair, there will be no minimum gain.
- The Dairy Wether must be a full blooded Dairy goat: Alpine, Nubian, Lamacha, Oberhasli, Saanens or Toggenburgs.

Superintendents will work together with members in this project to make sure buyers know the difference in dairy wethers vs boer goats. There will be a separate buy-back price for dairy wethers.

Superintendents will be looking for breeders that will have kids in January since we didn't know in time to breed ourselves.

All members participating in this or other livestock projects (excluding Dog and Horse) will need to have a current MQA. If this is the member's first market animal project participation, they will need to take the marketing class as well to be able to sell at the fair.

Meat Quality Assurance

Who:

Anyone who's is taking a livestock project (excluding horse) for the first time. First year seniors taking an animal project (turned 14 by December 31, 2020). This is not optional.



Curriculum Orders!


We will be doing a curriculum order for all fully enrolled 4-H members on February 2.

The cost of curriculum has increased significantly. In an effort to not raise enrollment fees, 4-H members will receive a book for projects one time (ex. beef, sheep, goats, shooting sports, etc) per family with the exception of project books that have activities that need to be filled out and turned in with fair projects (ex: most indoor projects) including those that have different books for each unit.


As curriculum comes in, we will notify club leaders for pick up. If you need an additional copy of a curriculum book, please call the Extension office.

Monday Night Marketing Webinar Series Coming in February

(Sterling, Colo.)

Many agricultural producers don't feel confident in their abilities to market the commodities they produce. In today's agricultural business environment of low commodity markets, high input costs and slim or non-existent margins, marketing skills are essential. In an effort to help farmers and ranchers improve their marketing skills, CSU Extension Ag Economist, Dr. Brent Young is offering a series of ag marketing webinars.

The Monday Night Marketing webinar series is two programs in one. The first meant to be an introductory course covering the mechanics of cash, futures, and options markets. This four week series is designed to meet the needs of agriculture producers who are new to commodity marketing and are looking for techniques to improve the prices they receive for their crops and livestock.

The final four sessions are a more advanced course that will focus on sophisticated marketing techniques and the development of a farm/ranch level marketing plan. These sessions are designed for producers who have a basic understanding of the topics presented in the introductory course.

The webinar format is interactive and will allow for live questions. Each webinar session will be recorded for review if you miss a session or for additional viewing to clarify concepts.

The webinars will be held from 7pm to 9pm, Mondays in February (8, 15, & 22) and March (1, 8, 15, 22, & 29). You can register for each session separately for \$15 or both sessions for \$25.
